
The Director of School Education, Puducherry is pleased to grant provisional permission / recognition to the following private school as detailed below:

- (a) The management is hereby instructed to renew the Fire NOC from the Fire Service Dept., and Sanitary Certificate from the Health & Family Welfare Dept., within Six months time.
- (b) The Endowment and Reserve funds should be increased by Rs.50,000/- and Rs.1,22,000/- respectively in the PSC Bank in Joint A/c with the Director of School Education, as per Rules.
- (c) Plan (PPA) Approval of the existing school building should be submitted, within six months time.
- (d) The Fee structure of the said school should be displayed in the Notice Board of the school.
- (e) The salary and the D.A., should be paid to the teaching and non-teaching staff, as per the Labour Dept., G.O.Ms. No.40/LAB/AIL/G/2013 dt.18.10.2013.
- (f) School Disaster Management Plan (SDMP) and School Safety Disaster Awareness Training Programme should be conducted, as per the instructions contained in the Circular No.7318 dated 09.03.2018, issued by the Joint Director (S.E), Directorate of School Education, Puducherry.

2. The management of the said school is informed that all the conditions as stipulated in the ANNEXURE to this Certificate and those prescribed in the Pondicherry School Education Rules, 1996 should be fulfilled failing which further continuance of recognition is liable to be rejected.
